

IN THE NAME AND AUTHORITY OF THE STATE OF TEXAS BEFORE ME, the undersigned authority, on this day personally appeared Detective J. Hinojos #1848, who after being by me duly sworn, on oath deposes and says that he has good reason to believe and does believe that heretofore to wit: on or about the 23rd day of August, 2006 through the 31st day of October, 2006 and before the filing of this complaint in the County of El Paso, the State of Texas, one Alberto Osegueda, Hereinafter called the DEFENDANT, did then and there unlawfully, commit the offense of Aggravated Sexual Assault by intentionally and knowingly causing the penetration of the sexual organ of a child younger than 14 years of age by any means.

The Affiant is in possession of an official police report and has personally observed the interview of the 6 year old female victim whose outcry was found to be credible. The child disclosed that while she was attending school at Lujan Chavez Elementary 2200 Sun Country in the City and County of El Paso, Texas and sometime between the listed dates, the 49 year old defendant took her into his office. While in the office the victim disclosed that the defendant pulled her skirt and panties down and sat her on his lap and proceeded to penetrate her vagina with his finger. The victim described the defendant moving his finger inside of her vagina. The Affiant asked that an arrest warrant be issued for the offense of Aggravated Sexual Assault an offense against the peace and dignity of the State.
